CURRENT PROJECTS

1 Report re suggested A24 Improvements

- A report was prepared giving recommendations for improvements to the A24 from the Washington to Offington roundabouts which was submitted to West Sussex County Council (WSCC) as part of their 2025 consultation process.
- An email was received by return thanking FPC for the recommendations which were based on suggestions from local residents and councillors.
- Action Complete.

2 Reduce the speed limit on Cissbury Ring Road

- An electronic and paper survey was produced requesting feedback from local residents to the proposal to reduce the speed limit on Cissbury Ring Road from 60mph to 20mph.
- The survey was promoted in an article in Findon News, using a QR code on posters around the village and hard copies of the survey are available in The Village Shop until the end of November 2025.
- More than 40 responses so far. The responses will be reviewed in December to gauge village support for the plan before proceeding to the next stage.
- **Next Stage** Following the results of the survey, Cllr Kenna will lead a group putting together a Traffic Regulation Order (TRO) for submission to WSCC.
- Signs for road two signs have been sourced for approval / discussion. Cyclists
 Please Slow Down / Take Care Slow Down Hidden Entrance which would be
 placed on the downhill side of Cissbury Ring Road before the houses at the top
 of the Green. Budget £30-100.

3 Making School Hill One way

- The same survey includes requests for feedback about making School Hill into a one-way street. The responses need to be reviewed before moving to the next stage.
- **Next Stage** Following analysis of the results of the survey, Cllr Dean will lead a group putting together a Community TRO for submission to WSCC.
- Cllr Dean to also liaise with WSCC with regards to applying for signage to reduce the size of vehicles using School Hill.

4 Moving the bus stop on the High Street

- Following a meeting with Gary Jannaway with WSCC Highways team, a response was received from the WSCC Public Transport team regarding the proposal to move the northbound bus stop from outside the Gun to outside the Village Hall.
- Next Stage review this feedback at the next council meeting before proceeding further.
- Cllr Kenna to contact Greypoint House management company about putting a sign on their wall opposite the Gun entrance asking people not to park there.
- Cllr Kenna to contact WSCC re the possibility of a solid white line on the road next to Greypoint House to discourage parking.

5 Repainting road markings and cleaning signs

 Cllr Kenna to use WSCC website to report road markings and signs that need repainting or cleaning.

6 Village Hall Parking

- Meeting with VH committee and school to be progressed
- Following a meeting with Gary Jannaway from the WSCC Highways Team, he suggested that there might be budget available to build a path from the Village Hall car park to the back of the school to make a safer entry for children moving forwards. This depends on support from the school and from the Village Hall committee to the plan to allow parking in the Village Hall car park at school drop off and pick up times.

7 Misc Suggestions / Comments

- Cllr Kenna has written and complained about the trees in central reservation and the chestnut tree on A24 following an appeal from a local resident.
 Unfortunately in both cases, WSCC does not feel that the issue reaches a threshold for them to take this further.
- Future projects
 - Reduce speed limit up to Northend
 - o Resurface car park at Pond Green
 - Parking issues next to Findon Rest
